REGISTRATION

Registration for EHS 2017 is to be made electronically by completing the respective registration form provided on the EHS 2017 website (www.ehs2017vienna.com). Registration forms without full name, complete email, postal address and date of birth cannot be processed. Registration fees depend on the date your payment is received at the EHS 2017 bank account and will be considered as incomplete and adjusted accordingly if the payment is not received by the relevant deadline. The relevant EHS 2017 registration deadlines are announced on the EHS website (www.ehs2017vienna.com).

REGISTRATION DEADLINES

Early Registration Deadline: until March 12, 2017 (23:59 CET)
Late Registration Deadline: until May 7, 2017 (23:59 CET)
Onsite Fee: from May 24, 2017 onwards

MEMBER REGISTRATION

Reduced member registrations are available to all active EHS and AHS Member in 2016.

RESIDENT REGISTRATION

Reduced resident registrations will be offered to young surgeons in training. Residents have to upload a written confirmation letter during the online registration process signed by the head of department, confirming their status as such. In case this confirmation is not received, the registration fee will automatically be adjusted to a regular fee.

STUDENT REGISTRATION

Reduced student registrations will be offered to students without any academic title. Students have to upload a copy of their valid student picture ID during the online registration process. In case this confirmation is not received, the registration fee will automatically be adjusted to a regular fee. The age limit for a registration as Student is set at 30 years (incl. the age of 30).

PAYMENT

Payment of registration fee can be made either by bank transfer or by credit card (VISA or MasterCard). Payment by cheque or in any other way is not accepted. Registration fees depend on the date the payment is received at the EHS bank account and will be considered as incomplete and adjusted accordingly if the payment is not received by the relevant deadline.

BANK TRANSFER

Payments should be made without charges for the beneficiary. Any bank charges will be collected onsite. For payment via bank transfer, clearly state the participant's name(s) matching with the name(s) on the registration form.



CANCELLATION

Notice of cancellations must be made in writing by email or fax to the congress office. Registration fees may be refunded as follows:

Written cancellations received:

- Before March 12, 2017: 75% refund
- Between March 13 and April 30, 2017: 25% refund
- After May 1, 2017: no refund

The date of receipt of the email or fax will be the basis for considering refunds. Please state your bank details (IBAN and BIC) on your written cancellation. Refunds will be made after the congress.

NAME CHANGES

Name changes will be treated like the cancellation of one registration and the new registration of another participant. New registration and payment are required.

BADGES AND SAFETY

The safety of all meeting delegates and participants is of utmost importance to the EHS 2017 congress office. Security measures and precautions at the EHS 2017 venue have been tightened to ensure maximum security for all attendees. Badges must be worn visibly on the meeting grounds at all times. The EHS 2017 congress office reserves the right for staff to check participants' identification upon admission to and/or inside the meeting venue. Participants may at any time be requested to present adequate proof of identity in the form of a passport, driver's license, national or military identification or student ID. Documents for the proof of identity must include a photograph and signature.

MEETING MATERIAL

The meeting material (badges, etc.) will be made available to the participant onsite at the relevant terminal(s).
